



(Limited 1 Year Warranty)

Manion's Wholesale Building Supplies Inc, provides a limited warranty to the original owner for one year from the date of the original invoice as long as proper installation, care, and maintenance guidelines are followed. This warranty covers defects in material and workmanship that will affect the performance of the finish.

Including but limited to

- Cracking
- Peeling
- Checking
- Runs
- Missed/Scant Finish
- Bubbling

## **This Warranty Does Not Cover:**

- Color variation due to wood graining
- Bleaching
- Discoloration due to Yellowing, Fading, or environmental conditions
- Dark color Paints and stains fading

Dark colored stains will sometimes appear as blotchy and dark pigment paints and stains will fade over time. Darker stains and high gloss paints also tend to highlight even the subtlest of surface conditions. These are **NOT** covered under this warranty.

Interior Doors must be sanded with 220 grit sandpaper to remove all scuffs and handling marks as well as any imperfections in factory sanding. Once sanded, brush door clean of dust or use compressed air. Water in the lines of compressed air can create spots in the stain and will void the warranty. All doors must be pre-sealed before staining. Not doing so results in sever blotching in the stain and sanding scratches may be more visible. If imperfections become more visible after staining they must be corrected before the top coats are applied as they cannot be repaired afterwards. Do not continue finishing if appearances of the first door doesn't meet expectations. Doors must be finished on sides and edges including the top and bottom. Doors must be prefinished within 15 days or the warranty will be voided.

Manion's will **NOT** be responsible for the appearance of any field finished doors.

Thorough attention and time are taken to blend color standards, variations do occur with the graining and hue of each individual piece of wood. The color of finished product will vary due to a number of characteristics inherent to each individual piece of wood.

If Manion's Wholesale Building Supplies elects to provide a replacement product, the limited warranty on the replacement product will last for the balance of the warranty on the original product.

Manion's Wholesale Building Supplies reserves the right to modify or discontinue any of it's products without notice.

Manion's Wholesale Building Supplies maximum liability is the purchase price of the product. Finish, installation, and maintenance costs are not covered by this warranty.
